plastic: your soup can becomes a bicycle bell.



We sort your plastic, cans and drink cartons type by type. For example, plastic packaging becomes new shampoo bottles, tin becomes new **cans** and drink cartons are used to make roof tiles, among other things.

What is allowed with plastic, cans & drink cartons?

- Plastic food packaging
- Vials of detergent, shampoo, soap
- Packaging of toothbrushes, screws and toys (blisters)
- Film from magazines and advertising brochures
- Plant pots (the pot that surrounds the plant when you buy it)
- Plastic bags and bags
- Coffee packaging
- Squeeze bags (including cat food, dairy)
- Blisters
- Chip bags
- Cartons (beverages, dairy)
- Packs of soup and pasta sauce
- Beverage and food cans
- Steel syrup bottles
- Aluminum foil and trays
- Tea light cups and beer caps

What belongs to plastic? Do the check:

- is it a packaging?
- is it empty?
- is it coming from the kitchen
- or bathroom?

3x yes?

Then it belongs to plastic, cans and drink cartons. Exceptions: Aerosol cans, these belong with residual waste.

Please note: There is a deposit on small PET bottles and drinks cans. Hand this in at a collection point.

how does the recycling rate work?

In Hendrik-Ido-Ambacht we separate our waste better and better, but there is still a lot of reusable material. Consider, for example, food scraps and plastic. If you separate waste properly, you will have much less residual waste, which is better for the environment!

From January 1, 2024, the municipality of Hendrik-Ido-Ambacht will introduce the recycling rate. The waste levy then consists of a fixed and variable part. The height of the variable part is determined by the number of times you use the underground container for residual waste or place the residual waste bin on the road. If you separate your waste properly, you will also have to throw a bag in the underground container or have your bin emptied less often. This way you have influence on the amount of the variable part of the waste tax. More information can be found at: h-i-ambacht.nl/recycletarief



Situation from 1/1/2024: The amount you have to pay for the variable part depends on the number of times you throw a bag of residual waste in the underground container or put the residual waste bin on the road. Other waste flows remain free.

How much waste on average ended up in residual waste per person in 2022? 206 kilos! But a small part of it was real residual waste. The rest can be recycled if you separate it properly and throw it in the right bin. In 2022, the residual waste consisted of:



In addition, there is 19 kilos of bulky waste per year.

organic waste and food scraps: your banana peel becomes compost.



We make green gas and compost from your organic waste and food scraps. For example, we turn an old bunch of flowers into green gas and your fish bone becomes compost.

What is allowed with organic waste and food scraps?

- · Peels and remains of vegetables, fruit and potatoes
- Food scraps (including fish bones, shells and meat bones)
- Cheese rinds without plastic
- Bread, pasta and rice
- Eggshells
- Peanut and nut shells
- Spoiled food



- houseplants
- Weeds, small pruning waste,
- grass clippings and leaves
- Manure, hay and straw from small pets such as rabbits and hamsters
- Tea bags, loose tea leaves, coffee pods, coffee filters with coffee grounds

waste paper: your love letter becomes toilet paper.



What is allowed with paper?

- Egg cartons, toilet and kitchen rolls
- Gift wrapping paper, greeting cards
- Post-its, notes, shopping lists
- Envelopes, also with window (without bubble wrap)
- Writing and drawing paper
- Old newspapers and magazines
- Broken reading and comic books • Advertising brochures (without the plastic packaging)
- Paper bags and carrier bags

- Fax and copy paper Cardboard and paper packaging for choco-
- late sprinkles, tea, rice, cookies, beer and frozen pizza
- Cardboard packaging of mascara, cream, perfume and medicine
- Cardboard wrappers for desserts and meal salads
- Receipts
- Cardboard boxes

residual waste: only a little bit left.



- Chewing gum
- Pizza boxes with food scraps or grease

- Broken shopper shopping bag
- Used tissues, paper towels
- Vacuum cleaner bags

Residual waste is incinerated in our waste-to-energy plant. Heat is released during combustion. We use this to produce heat and electricity. After burning, so-called bottom ash remains, which are reused in **asphalt** for roads.

What is allowed with residual waste?

- Chip cookers
- Wet and/or dirty paper and cardboard,
- such as baking paper and butter wrappers
- Styrofoam packaging, such as fast
- food packaging and meat trays
- Razor blades
- Hydro granules
- Matches and matchboxes
- Plastic-coated paper, cardboard, photos

- Corks
- Organizers, ring binders, storage folders
- Sanitary towels, tampons, incontinence materials and diapers
- Aerosols (whipped cream, hairspray, deodorant)
- Envelopes with plastic bubbles
- · Filling material for pillows and cuddly toys
- Ash from ashtray, fireplace and barbecue
- Birdcage sand and cat litter pellets
- Face masks and disposable gloves
- Coffee cups
